2. Appointment of Tellers: -

Anna Gray proposed by Phil Caisley and seconded by Kari Martin: A show of hands was requested via the 'raised hand' function to approve Anna's appointment. **APPROVED**

Mark Pearce proposed by Chris Michael and seconded by Derek Marshal. A show of hands was requested via the 'raised hand' function to approve Mark's appointment. **APPROVED**

3. The 17th October 2020 Annual Consultative Meeting Minutes:

The Minutes, circulated with the agenda and on the SRC website.

The approval of the minutes as circulated was proposed by Kari Martin and seconded by Paul Dimmock. A show of hands was requested via the 'raised hand' function to approve the minutes as a true record of the meeting **APPROVED**

4. Matters arising not covered by the agenda: None

5. Chairman's Report: TS

Written report, circulated with the agenda and on the SRC website

The report outlined the vision and core philosophies and aims to promote and attract more paddlers into sprint racing, and for more to stay in the sport longer. Tim also especially wished to thank all the club volunteers and regatta officials for the extra work involved holding covid secure events this year. To conclude his report the Chair, congratulated all the athletes on their achievements this year, overcoming all the many extra difficulties caused by the pandemic.

6. Treasurers' Reports: LC

Sprint Racing Committee & Regatta Committee Treasurer's End of Year Reports, circulated with the agenda and on the SRC website

a) Sprint Racing Committee End of Year accounts up to 31/10/2020

Louise gave a brief explanation of the accounts and ask for any questions:

Several members questioned the low level of the British Canoeing funding support for the SRC. Particularly the level of funding support for the national regattas which include selections for the major international events. Often the selection regattas are run at a financial loss for the Regatta Committee and rely on volunteers giving support to hold the events.

Louise commented that British Canoeing had underwritten any losses for the 2021 April selection event which was held under strict DCMS Elite Sport Exception covid rules, this had been a 'one off'.

The British Canoeing grant to the committee is documented in the End of Year Balance sheet, the Royal CC Voting Rep, asked if the total value of British Canoeing support, financial and 'in kind' (staff support) for sprint racing was known, including indirect expenditure such as the Start Gates etc. This information is not easily available, AG would follow up on this question later.

Another question was raised whether the Welfare Unit at South Cerney funded by the SRC was retained as a SRC asset. Louise replied, she didn't know the background as the agreement to fund the unit was made before she was Treasurer. Tim stated the records would be checked to establish if it is or not.

The Chair requested the SRC Accounts be approved. Vote by a show of hands. **APPROVED**

b) Regatta Committee End of Year accounts up to 31/10/2020

LC gave a brief explanation of the accounts, there were no questions raised.

The Chair requested the RC Accounts be approved. Vote by a show of hands. **APPROVED**

c) The Treasurer gave an outline of the expected financial position at the end of the current financial year (up to 31/10/2021). Explaining that the SRC had used some of their reserves to fund the Live streaming of the National Regattas this season. Due to the covid protocol of 'no spectators' at events, the SRC consider the streaming a priority and a worthwhile future investment for the sport. The challenge is to move towards, live streaming being self-funded
Several attending members spoke of their appreciation of the introduction of the live streaming and support for this to continue for all national regattas.

A question was asked, that historically the intention was to use the reserves to replace the timing system for the national regattas, is that still the case. Louise replied the SRC did still plan to replace the timing system, the option now being investigated with British Canoeing's help, is the possibility to expand the planned upgrade of the Timing system as part of a new competition software package.

9. Regatta Committee 2021 Report: PC

Written report, circulated with the agenda and on the SRC website.

While it was pleasing to be able to return to holding sprint competition the changing covid restrictions did pose and increase burden on the Regatta Committee as we were unable to plan or operate to the usual timescales. The Regatta Committee wish to say a massive thank you to our wonderful band of volunteers, officials, and the British Canoeing event staff, we appreciated your support and the significant input you all made throughout the season, the regattas could not have happened without you.

Also, thanks to the clubs who adapted to the On-line Team Leaders Meeting, WhatsApp group for comm, and submitting crew change forms electronically among other changes, all due to the covid protocols. We will be reviewing the effectiveness of those changes, the best of which will be taken forward for the coming year. It was great to be able to reintroduce some normality to the regattas by the September event.

We are all looking forward to 2022, planning for the National Regattas has already started but the dates can't yet be firmed up but will be shared soon.

10. Announcement of the Results of National Sprint Competitions and Awards.

As we are meeting for the ACM on-line, presentations of these awards will be arranged over the coming months at the athlete's clubs or other suitable social occasions.
